Judge Upgrades

The Judges working group have been working hard to bring the exam and seminar elements of the upgrade away from Lilleshall and increase the number of days if possible. A trial was carried out (sorry Claire, didn't mean to spring it on you) last month and I'm pleased to say that it worked and we are now pushing for a roll out of the seminar being carried out through learning curve in the form of webinars and the exam being carried out at regional level under exam conditions. This has not been formally accepted by AGB but watch this space.

Reporting

As you may or may not know, in order to comply with the requirements for upgrades and reaccreditation, we have to report the number of judging days we all carry out to AGB, these include the seminars/conferences you attend. It the past we completed a form J7 and forwarded this to the County SPOC for inclusion in their report to myself and a regional report was compiled before sending to AGB. We now have the opportunity of reporting via an online portal but not a lot of you are using this facility. It is a very easy process and shoots can be reported quickly. It would greatly assist your SPOC and myself if you could ensure you report electronically. Please make sure you still collect your J5's for your judging days.

Judge Uniform

Yorkshire are using an alternative judges shirt which we are attempting to have approved by AGB. I believe these are a little cheaper than those provided by AGB and I am told are of a better quality. Please be aware that these shirts do not form part of the reimbursement scheme by NCAS.

Bow Scales

The bow scale certification at Regional Level is now approved and I have everything we need to certify the NCAS Judges Scales. These will be carried out for those in attendance at the next conference in October. Should you be unable to attend the conference and would like your bow scales certified, please fill in the certificate attached and give them to a judge who will be attending. Priority will be provided to those who are actually at the conference and I would request that each attending judge only bring a maximum of three sets of scales (including their own). Please don't be offended if you send your scales with another judge and they aren't certified due to time constraints etc.

National Conference

I have still not received details from those of you who attended the virtual National Conference in March. Please let me know if you attended so I can update the JLO records in readiness for the questions from AGB before this year's National Accreditation Exam.
